Times are 10am to 2pm. Set up can begin from 9am.

You must be self sufficient with a 3m x 3m gazebo and your own tables etc.

Entrance is via the north gate at the festival site. Committee members will be wearing bright pink Hi-Viz vests, so you can see us clearly to find out where to set up. Alternatively, call Tracy on 0427642010. Signs will be erected to guide you.

The gates will be unmanned on Sunday, as most of the festival attendees are here for several days. The site is for FREE, but if you would like to make a donation to the LCCMM Inc, it would be appreciated.

If you would like to attend the Music Marathon on Saturday or arrive on Saturday ready for Sunday, you will need to buy a weekend ticket.

It is a requirement to show proof of public liability to be able to be able to trade at Lake Charlegrark. Please send a copy prior to the weekend to the email address at the end of this letter.

In Victoria, all organisations or individuals that prepare, sell or serve food are regulated by local councils under the *Food Act 1984 (Food Act)*. Therefore, all food traders are required to apply for a Food Trader registration and provide a copy of the 'Statement to Trade' prior the weekend to the email address at the end of this letter.
